### COMMUNICATING EUROPE SEMINAR: SWEDISH PERSPECTIVES ON ENLARGEMENT

**Monday 25 – Tuesday 26 May 2009**

**Dužanka Basta** is the Assistant Minister for the Coordination of International Economic Aid in the BiH Ministry of Finance and Treasury. She was previously Head of the International Aid Coordination Department at the Ministry of Foreign Trade and Economic Relations. She also acted as the Team Leader and National Professional Expert of UNDP's Programme of Support to BiH. Before becoming Department Head, Dužanka Basta was the senior official in the Trade Ministry responsible for preparing negotiations and conducting all activities before the signing of financial agreements with donors, such as the World Bank, EBRD and EIB. She has also served as the National Co-ordinator for the Netherlands PSO Programme for Economic Cooperation with BiH, as well as the BiH Representative for Environment Investment Projects within the EC General Secretariat for Environmental Protection. She worked previously as Head of the Department for Investments and Insurance at the BiH Public Railways Enterprise. Dužanka Basta holds a B.Sc.Oec (Economic Science) from Sarajevo University, a Civil Service Diploma and a Macroeconomics Diploma for Central and Eastern European Countries from JICA, Japan.

**Ines Troha Brdar** is the Head of the Department for CFSP and ESDP at the Croatian Ministry of Foreign Affairs and European Integration. She also co-ordinates Croatia's participation in the EU's foreign policy and ESDP missions. She is a member of the EU Integration negotiating team, and heads the Working Group for Chapter 35. She is acting head of the Chapter 31 Working Group. She was previously head of the MFA EU Department. She was responsible for co-ordination on the European Neighbourhood Policy, EU and Serbia, Montenegro and Kosovo, and security procedures for exchanging data with EU. A career diplomat she has also served in Croatia's missions in Chile and Slovakia.

**Fatmir Curri** is a project coordinator and one of the senior experts at the Kosovar Civil Society Foundation (KCSF). Fatmir Curri is a lecturer at the Kosovo School for European Integration. Fatmir Curri also lectures and trains youth NGOs in Kosovo on EU enlargement policy, EU funding and advocacy and lobbying practices for NGOs. Fatmir Curri worked previously as a senior officer for the Stabilisation and Association Process Tracking Mechanism at the Agency for European Integration in the Office of the Prime Minister of Kosovo. He also did an internship at the European Parliament in Brussels. He has worked in the past within the OSCE mission in Kosovo and for several international NGOs working in Pristina. He was a junior economic researcher with the Riinvest Institute working on an early warning project mainly covering SMEs. Fatmir Curri has a degree in Banking and Finances from the Faculty of Economics, University of Pristina and holds a Master's Degree in European Studies from the Catholic University of Leuven, Belgium. He has also taken part in an intensive seminar on European affairs at the College of Europe in Bruges.

**Arian Galdini** is the founder and the Executive Director of Forum for Democracy and Ethics (FDE). In 2007 he was Director of the Cabinet of the Minister of Tourism, Culture, Youth and Sports. He was Executive Director of the Albanian Free Forum (AFF), an organisation designed, founded and run by a group of young people engaged in politics, from 2002 – 2008. Arian founded and since 2004 has led and moderated monthly meetings of the Leadership Forum which aims to build a network of leading political leaders, academia, judges, and civil society organisations. Arian Galdini joined the

Democratic Party as soon as it was established in 1991. He has since founded and/or chaired the Youth Forum of the Democratic Party of Albania in Vlora, and the Student Committee for National Reconciliation. He first joined the student movement to oust the Communist dictatorship in Albania in 1990.

**Zara Halilović** has been Assistant Director responsible for the co-ordination of EU funds for the BiH Directorate for European Integration since October 2007. She has dealt with issues related to the co-ordination of EU funds since January 2004. In 2006 Zara Halilović participated in the activities of the BiH negotiating team regarding financial issues and the use of EU assistance. She has published several specialised essays and research papers on EU integration and the use of EU assistance. Zara Halilović has a M.A degree in European Studies from the University of Sarajevo and Bologna.

**Srdjan Gligorijević** is the Senior Political Officer (EU Affairs) at the British Embassy in Belgrade. Until April 2009, he was the Director of Analysis at the ISAC Fund (International and Security Affairs Centre), a prominent Belgrade based think-tank. He has been a Visiting Research Fellow at the NATO Defense College-Rome (2008) and at the European Union Institute for Security Studies-Paris (2006). Srdjan Gligorijević worked previously as Head of Research at the Defence and Security Studies Centre, at ESPI Institute, where a number of his articles were published in regional and international journals and publications. His special interests are in CFSP/ESDP, NATO, international politics, diplomacy, intercultural issues and history, especially related to the Balkans.

**Arben Kashahu** has been the Secretary General of the Ministry of European Integration in Tirana since February 2006. He was Director of the Cabinet of the Minister of European Integration, from 2005 to 2006. Previously, he was a Senior Legal Advisor of the Foundation for Local Autonomy and Governance. He also worked as a private attorney, providing legal expertise for many national and international agencies, private companies and individual clients. He is a lecturer at the Faculties of Law at the private University Kristal and at the private European University of Tirana. He was awarded an M.A. in Governance and Politics of European Integration by the University of Bologna in 2003. Arben Kashahu was licensed as a lawyer by the Bar Association of Albania in May 2000. He was awarded his B.A. by the Jurisprudence Faculty, University of Tirana in 1999.

**Tomislav Kaznačić** has been the EU Economic Officer in the British Embassy in Zagreb since 2005. He has closely followed Croatia's accession negotiations process and the economic scene in Croatia. He has worked for the British Embassy since 1992 in a number of Embassy sections. He has a Bachelor's degree from the University of Zagreb in English and Italian language and literature.

**Ksenija Milivojević** is advisor on European affairs to the Deputy Prime Minister of Serbia. She is responsible for EU affairs, the European integration of Serbia and the Western Balkans, foreign policy and international relations. Ksenija Milivojević was an MP from 2004-2006; she chaired the standing parliamentary committee on European integration, which is in charge of reviewing laws with respect to their compatibility with the *acquis communautaire*. She served as the Secretary General of the European Movement in Serbia, an NGO dedicated to the acceleration of the European integration process from 2006-2007. From 1998-2002 she worked in the Embassy of Israel in Belgrade as a political advisor to the ambassador. Ksenija Milivojević has a degree in law and has specialised in European studies and international relations. She is currently studying at a graduate course in international relations and foreign policy at the Faculty of Political Science in Belgrade. She has published several articles and essays, mainly on the European integration policy.

**Milan Pajević** is one of the founders of the ISAC Fund (International and Security Affairs Centre). He served as CEO of the G17 Institute (ESPI Institute) in 2004 and 2005. He was the chief foreign policy adviser to the Serbian Deputy Prime Minister from 2004 to 2005. Since the formation of the G17 Plus party in 2002, Milan Pajević has chaired the International Affairs Committee of G17 Plus and was G17's Vice President for International Relations. He was one of the founders of the G17 Plus expert network (NGO) in 1999 and its foreign policy adviser. Milan Pajević held the post of

Ambassador at the MFA, served as a Foreign Policy Adviser to Deputy Prime Minister of FRY and the National Coordinator of the Stability Pact in the first democratic government after the fall of Milosević. In the 1990s, he was the Vice President of the European Movement in Serbia in charge of international cooperation (from 1994 to 2000) and he worked in the publishing house Vreme knjige, later renamed into Stubovi kulture. Milan Pajević lived and worked in the private sector abroad from 1991 to 1993. Milan Pajević holds a B.A. in Political Science and International Relations awarded by the Faculty of Political Science, University of Belgrade.

**Aleksandar Pejović** is the Director of the EU Directorate of the Montenegrin Ministry of Foreign Affairs. He has also been a Counsellor in the Multilateral Department, where he was Head of the UN Unit and of the Regional Initiatives Unit. He also worked in the Bilateral Department (Western Europe) and in Montenegro's Mission to Slovenia. He joined the Ministry in 2000. Aleksandar Pejović has an MA in Political Science and Public Administration from the National and Kapodistrian University of Athens.

**Adnan Rondić** is the editor and presenter of a documentary programme and a special news programme at the independent TV station, NTV Hayat in Sarajevo. He has worked there since February 1992 as a journalist, presenter and editor. He was the author and the host of the political talk-show Step ("Korak"), which ran for 8 years until December 2007. The programme hosted around 1,500 interviewees including senior Bosnian and foreign officials, representatives of the international community in Bosnia and Herzegovina, religious officials, and ordinary Bosnian citizens. From 1995 and 2000, he was the chief executive editor of the news service on NTV Hayat. In addition, he has also been reporting for the Voice of America since 2001. He graduated from the Department of Classical Journalism and the Department of Business Communication at the Faculty of Political Sciences in Sarajevo. Currently, he is enrolled in the graduate programme Diplomacy in the Contemporary World at the Faculty of Political Sciences in Sarajevo.

**Engjellushe Morina** is Executive Director of Iniciativa Kosovare per Stabilitet (IKS) based in Prishtina. Prior to her joining IKS she was responsible for the Higher Education portfolio at the Public Diplomacy Section at the U.S. Embassy in Prishtina. Engjellushe Morina was responsible for Educational Programs and Exchanges such as the Fulbright and Hubert Humphrey Fellowships. During the Kosovo status negotiations, Engjellushe Morina served as an expert and consultant in the Cultural Heritage group within the Unity Team. Her input focussed in particular on the protection of cultural and religious heritage in Kosovo. Engjellushe Morina's initial training was in Archaeology; she gained her BA (Hons.) from the Institute of Archaeology at the University College London (UCL). Engjellushe Morina also has a graduate degree in diplomatic studies from the University of Oxford, UK. In 1999, Engjellushe resolved to return to Kosovo she helped set up the third largest political party.

**Lila Radonjić** is the Director and Chief Editor of the independent TV production group Mreza in Belgrade, established in 1997 by a group of journalists ousted from Studio B by the Milosević regime. She has worked as a journalist and news editor since 1974. Lila Radonjić won the Jug Grizelj Award in 1990 for professional, independent and investigative journalism. In 2007, she received the Seizing Freedom Award for enhancing democracy and freedom in Serbia's society. She is the author of the book »Our Case«, published in 1996. She has lectured at schools for journalism in Sarajevo, Novi Sad and at the Alternative Academic Network of Belgrade and she is a member of the Independent Association of Journalists of Serbia. She has also worked as a mentor in journalism at the Faculty of Political Sciences, University of Belgrade since 2000. She has a Bachelor's Degree in journalism.

**Malinka Ristevska-Jordanova**, State Counsellor at the Macedonian Government's Secretariat for European Affairs, is responsible for co-ordinating Macedonia's pre-accession policies. She is the co-chair of the Stabilisation and Association Committee EU - Republic of Macedonia. She has also been active in regional co-operation, promoting ownership and co-operation in the EU integration process.

**Goran Rotim** is a senior journalist at Croatian public TV (HTV). He was Deputy Chief Editor of the HTV News Programmes, where as a senior manager, he was responsible for 320 journalists, and more than 20 shows, from 2004 to 2007. He was also co-editor of the prime-time news programme “Dnevnik” from 2006 to 2007. He has made documentary films; “*Hungary - a Stew for Europe,*” and “*Czech-the Process,*” and he is a co-author of the film “*Austria - the Secret of the Danube Mainstream.*” In 1994-96, he was editor and anchor of the daily news show “Slikom na sliku,” which featured foreign TV coverage and views of Croatia. In 1991-92, he was a war reporter in Croatia and Bosnia and Herzegovina. Outside television, he has been the Secretary General of the Atlantic Business Group, where he has been responsible for external and internal communications and PR since 2007. From 2000 to 2001, he was a Spokesman at the Croatian Ministry of Foreign Affairs, and from 1999 to 2000 he was Consul-Counsellor at the Croatian Consulate-General in Subotica, Serbia – his town of birth.

**Agneza Rusi** is the Director of the EU Directorate in the Ministry of Foreign Affairs in Skopje. She is currently the Deputy Chief Negotiator for visa liberalisation with the EU. She also headed the negotiation team on visa facilitation with the EU. Agneza Rusi entered the diplomatic service in 1996. She served as Second Secretary in the Macedonian Mission to the EU in Brussels from 1999 to 2003 and as Deputy Head of the EU Department in Skopje from 2003 to 2006. She graduated at the Faculty of Economics in Skopje and holds an MA in International Politics from CERIS in Brussels.

**Dijana Rusi** has worked as the Political Officer at the British Embassy in Skopje since it was established 15 years ago. Dijana Rusi works closely with the Ambassador and his deputy to ensure that the Ambassador and the Embassy as a whole are kept abreast of developments; reporting on political developments; maintaining a list of key political contacts; identifying and cultivating the local decision-makers and opinion formers; developing relevant contacts, particularly within the Government, Parliament and also in the media, political parties, NGO's and academia.

**Mentor Shala** is the programme editor and presenter of the programme “Europe closer” (Europa më afër) on Kosovo public service TV, Radio Television Kosovo. He was Head of News for 2 years. He edited the main TV news programme for a year. His previous jobs at RTK include Assistant Chief Editor and also reporter. He presented the investigative show Tema for six months and has moderated TV debates on ethnic issues. Before joining RTK, he was the political affairs editor of the daily newspaper “Epoka e re” in 2000. He has also edited INFO News and BLIC News. In autumn 1999 he reported from Kosovo on a daily basis for the Institute for War and Peace Reporting. He is the President of the Association of Professional Journalists, a member of the International Federation of Journalists.

**Bojana Stanišić** is the Executive Director and one of the founders of NGO “Center for Euro-Atlantic Politics” in Podgorica [www.evropskireporter.com](http://www.evropskireporter.com). She is also a journalist and news editor on the “Vijesti independent TV” channel, and the editor and presenter of the TV show, “Euroscope,” which reports on Montenegro’s European integration. She worked as the local producer of the documentary film “Wild Beauty” co-produced by ESI and the Austrian production company Pre TV, part of a series of ten documentaries on South East Europe. Bojana Stanišić worked previously as a journalist for the daily newspaper “Dan”, where she covered topics regarding EU integration for five years. She edited the “Dan in Europe” pages. She also works as a Montenegrin contributor for BIRN (Balkan Investigative Reporting Network) and for its international on-line publication Balkan Insight [www.birn.eu.com](http://www.birn.eu.com). In May 2007, she was awarded a Balkan Fellowship for Journalistic Excellence. She studied at the University of Montenegro and took the advanced level BIRN journalism training programme.

**Boris Vujčić** is Croatia's Deputy Chief EU negotiator and Deputy Governor of the Croatian National Bank. Prof. Vujčić's fields of expertise are macroeconomics, international finance and labour economics. Boris Vujčić has also been an external collaborator for the International Labour Organization (ILO) and a consultant to the European Commission. He is also a Professor at the University of Zagreb, where he was awarded his BA, MA, and Ph.D. in economics.

**Ana Vukadinović** has been Head of the Secretariat for European Integration in Podgorica since December 2006. She is responsible for the co-ordination and supervision of the EU association and accession process; preparing the key documents, co-ordinating inter-ministry preparations for the negotiations, and monitoring the process of implementation, co-operation with EU institutions, and EU Member States, implementation of IPA and donor coordination, coordination of the accession-related translation process. Previously, she worked as an Adviser to the Deputy Prime Minister for Economic Policy and Development (2003-2006), as an economic advisor in the EC Food Security Programme in Montenegro (2000-2003), and as an advisor in the Ministry of Foreign Affairs (1999-2000). She was a media monitor and analyst for a range of media organisations including; ZDF, BBC, Reuters and the OSCE in 1998-99. Ana Vukadinović was awarded a MSc in International Business Management by the School of Management at the University of Surrey in 2005, and a BSc in Financial and Bank Management by the Economics Faculty at the University of Montenegro in 1999.
