

Not for lack of trying

Chronology of efforts to solve the Sejdic-Finci conundrum

Bosnia and Herzegovina has the smallest parliament in Europe. The lower house, the House of Representatives, has 42 members. For comparison the Estonian Rigiikogu has 101, the Slovenian National Assembly 90 members, Malta (69), Luxembourg (60) and Cyprus (56 seats filled).¹

In 2012 the Bosnian legislature adopted 8 ordinary laws and 3 budget laws.² During that year the lower house was in session 21 days, the upper house 17 days.

Now contrast this output contrasts with the amount of time and energy spent on discussing implementation of the Sejdic-Finci court case ... so far without any result.
